

**THE ROY D. GRAHAM "LIFETIME ACHIEVEMENT" AWARD
ELIGIBILITY CERTIFICATION FORM**

AWARD ELIGIBILITY CRITERIA

To be eligible for this lifetime achievement award the following criteria must be met:

- (1) The applicant must complete educational levels of certification, as follows:
 - a) DTM's earned before July 1, 1999, under the Able Toastmaster system ("Old System"), must also have completed requirements and registered either Able Toastmaster Bronze and Able Toastmaster Silver, or Advanced Toastmaster Gold.
 - b) DTM's earned since July 1, 1997, under the Advanced Toastmaster system ("New System"), must also have completed requirements and registered an additional Competent Toastmaster or any level Advanced Toastmaster designation.
 - c) In addition, "New System" DTM's must have given:

Ten presentations or seminars within Toastmasters, beyond that necessary for DTM, of the following type:

 - 1) Keynote or similar speech as District, Regional or International Conference/Convention
 - 2) Educational Seminar or Workshop at Area level or above, including District-Sponsored Club Officer Training or Learning Conference
 - 3) Success/Leadership or Success/Communication modules (includes Speechcraft)
 - 4) Youth Leadership

Four presentations to non-Toastmasters audiences that can be:

 - 1) Work related
 - 2) Community
- (2) The applicant must have at least ten consecutive years in Toastmasters before July of the year the award is presented, at least five of which shall be in District One.
- (3) All levels of certification must be completed. The individual must also serve at the district level in this district for at least one full year beyond that required for DTM. (This year may be achieved within the qualifying ten years membership To qualify for the additional year of district level service, an individual must:
 - a) Serve as a member of the District Executive Committee, or
 - b) Serve as a Committee Chairman appointed by the District Governor.

AWARD ELIGIBILITY CERTIFICATION

Individuals, who have completed the certification requirements more than once, only need to document one of each level of certification to ascertain eligibility. Other certificate registrations, District positions and Club Memberships held listings may be listed on a separate sheet.
